ANTI RAGGING RULES

Ragging is totally prohibited in **COLLEGE OF PHARMACY** campus, in case any student is found involved in the ragging the action shall be taken as per the instructions of the Hon'ble Supreme Court of India. Such cases will be investigated by the anti-ragging committee of the College. Student, found guilty, will be expelled from the College.

I - Anti Ragging Rules

As per orders of the SUPREME COURT ragging in any form is strictly prohibited.

a. **"Ragging" means the following:**

Any conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such students will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

b. **Punishable Ingredients of Ragging:**

- i. Abetment to ragging;
- ii. Criminal conspiracy to ragging
- iii. Unlawful assembly and rioting while ragging;
- iv. Public nuisance created during ragging.
- v. Violation of decency and morals through ragging;
- vi. Injury to body, causing hurt or grievous hurt.
- vii. Wrongful confinement;
- viii. Use of criminal force;
- ix. Assaults as well as sexual offences or unnatural offences;
- x. Extortion;
- xi. Criminal trespass;
- xii. Offences against property;
- xiii. Criminal intimidation; Attempts to commit any or all of the above mentioned offences against the victim
- xiv. Physical or psychological humiliation;
- xv. All other offences following from the definition of "Ragging"

c. Punishments

At the Institute level:

Depending upon the nature's gravity of the offence as established by the Anti-Ragging committee of the Campus, the possible punishments for those found guilty of ragging at the Campus level shall be any one or any combination of the following:

- i. Suspension from classes and academic privileges.
- ii. Withholding/withdrawing scholarship/ fellowship and other benefits.
- iii. Debarring from appearing in any test/ examination or other evaluation process.
- iv. Withholding results.
- v. Debarring from representing the Campus in any regional, national or international meet, tournament, youth festival etc.
- vi. Suspension/ expulsion from the hostel.
- vii. Cancellation of admission.
- viii. Rustication from the Campus for period ranging from 1 to 4 semesters.
- ix. Expulsion from the Campus and consequent debarring from admission to any other Campus for a specified period.
- x. Fine ranging between Rupees 25,000/- and Rupees 1 lakh.
- xi. Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the Campus shall resort to collective punishment.

Extracts of Fines and Punishment Policy : College of Pharmacy

S. No	Offence/Act/Behave	Punishment
1.	<u>RAGGING</u> Strictly prohibited as per orders of Hon'ble Supreme Court of India	Suspension and enquiry—Cancellation of admission/ suspension of attending classes/withholding or withdrawing scholarship or fellowship and other benefits/debarring from appearing in any test or examination or other evaluation process/withholding results/debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc./suspension or expulsion from the hostel/rustication from the institution for period from 1 to 4 semesters/ expulsion from the institution and consequent debarring from admission to any other institution/ fine of Rs.25000/ collective punishment— when the person committing or abetting the crime of raging are not identified and legal action/any other action as per directions of Hon'ble Supreme Court
